

**CALL FOR ARTISTS**  
**Estacada Summer Celebration 2010**  
**Art Fair Jury/Application Information**  
***Due Date: Friday, April 9, 2010***

The Estacada Summer Celebration announces the 6th annual Art Fair to be held in downtown Estacada, Oregon, on one day only: Saturday, July 24, 2010. The goals of the Art Fair are to:

- ✓ Promote local and regional artists,
- ✓ Educate the public about art processes and techniques through artists' demonstrations,
- ✓ Offer visitors an attractive mix of well-crafted, high quality, and original artwork.

NOTE: Not all work can be accepted due to space and the desire to create a balanced show with a variety of presentations each year.

**Important Dates - 2010**

April 9 – Jury/Application packets must be *received* by this date

April 25 – Artists notified of acceptance

June 13 – Artists information packets mailed

**Jury/Application Packet Checklist**

- ✓ Jury/Application Form, completed
- ✓ Booth Agreement, completed and signed
- ✓ Check for \$45 booth fee
- ✓ Photos, CD, or weblink of artwork for review by the jury (see labeling instructions below)
- ✓ Self addressed stamped envelope for return of materials (optional)
- ✓ Mailed as instructed or delivered to Estacada City Hall no later than Friday, April 9, 2010.

**Jury/Application Materials - Instructions**

The jury will consider applications by reviewing images submitted as photos, electronic files on CD, or weblink. Please submit no more than two images per item for no more than three items of artwork (maximum six images). If you plan to show and sell artwork representing more than one medium, submit no more than two images per item (maximum six images) for each medium. *Please choose the images that best show the quality and craftsmanship of your artwork.*

**Photos (Printed)** – On the back top of each photo print the artist's name and the number of the photo. Provide a list of photos including for each photo: The photo number, title of the work, dimensions, medium, price, and anything else you'd like the jury to consider.

**Electronic Images on CD** – Provide with the CD a hardcopy list of images on the CD including for each image: The image's file name, title of the work, dimensions, medium, price, and anything else you'd like the jury to consider.

**Weblink** – Provide website for viewing artwork, along with detailed information about the artwork such as title, dimensions, medium, price, and anything else you'd like the jury to consider.

Entry materials must be ***received by Friday, April 9, 2010***  
(See mailing or delivery addresses on Application Form).

*Please include a stamped self addressed envelope with your jury/application packet  
only if you want your materials returned to you.*

## Estacada Summer Celebration 2010 Art Fair Booth Agreement

I, the undersigned artist, agree to the following conditions for participating at the Estacada Summer Celebration 2010 Art Fair:

- I am including the \$45 booth fee with my jury/application packet. NOTE: Booth fee checks for artists who are not selected by the jury will be returned by mail. Booth fees for accepted artists are nonrefundable.
- Estacada Summer Celebration will provide a 10' by 10' space for me to sell artwork on Broadway Street between 10:00 am and 6:00 pm, Saturday, July 24, 2010. I understand the spaces are pre-assigned to provide a balanced flow of styles and media.
- I am responsible for providing a form of shade for my booth (EZ Up Tent, Shade Canopy, etc.), as well as water for myself and any staff. **NOTE: The afternoon sun will make the booths very hot. Please plan accordingly for your health and to protect your merchandise.**
- I am responsible for providing a manner of weighing down my form of shade to protect myself, my artwork, and the public from possible accident resulting from unexpected winds. (Example: At least two legs of a canopy are anchored in and firmly attached to a sand-filled 5 gallon bucket.)
- Summer Celebration staff will provide access to my booth area to begin setup no earlier than 8:00 am Saturday, July 24. *I will comply with the traffic flow as identified by Summer Celebration Staff.* **NOTE: Please bring help to insure you are off-loaded quickly so that other artists can access their booth space.**
- I am responsible for the security of my artwork, display materials and belongings the entire time: from setup beginning 8:00 am through tear down completing no later than 8:00 pm, on July 24.
- I am responsible for providing my own display equipment. **NOTE: There is no access to electricity or water at the booth. No generators will be allowed.**
- My booth will be set up and ready for sales no later than 10:00 am Saturday, July 24. My booth will be staffed continuously from 10:00 am to 7:00 pm Saturday, July 24. If I am not able to be present the entire time, I am responsible for arranging for another person to staff my booth in my absence. I will not begin tear down of my booth before 7:00 pm Saturday, July 24.
- I will share my booth with no more than one other vendor. The other vendor must complete and submit a separate copy of these forms. Only one vendor sends the booth fee check for \$45.00.
- I agree to leave my booth area free of trash and any other items by 10:00 pm, Saturday, July 24. Estacada Summer Celebration staff will provide trash receptacles for my use.
- The Estacada Summer Celebration Planning Committee reserves the right to ask artists to remove work they feel is unsuitable for the Estacada Summer Celebration 2010 Art Fair.
- A Silent Art Auction will be held to support the Estacada Summer Celebration. **Artists are encouraged to contribute an item for this important fundraising event. Proceeds go toward next year's Celebration.** Donation of an item to the Silent Auction is not a condition of this agreement.
